SETTING THE RETIREMENT AGE LIMIT FOR THE PERMANENT PERSONNEL OF THE PAN-AFRICAN AGENCY OF THE GREAT GREEN WALL (PAGGW) AND REVIEW OF ARTICLE 68 OF THE PAGGW PERSONNEL REGULATIONS

- <u>Article 1:</u> Fixes the retirement age limit at sixty-five (65) years for Category II personnel, professional civil servants and at sixty-two (62) years for Category III, general service, and auxiliary civil servants.
- Article 2. Article 68 of the current Personnel Regulations of the Pan-African Agency of the Great Green Wall relating to activity is therefore revised: The activity is the position of the civil servant who performs the functions pertaining to the job assigned to him/her and in accordance with the needs of the Agency. During the period of activity, the retirement age limit is set at sixty-five (65) years for Category II staff, relating to professional civil servants, and sixty-two (62) years for Category III, relating to General Service and auxiliary civil servants. The official may, for operational purposes, be transferred, or placed in a position of mission, secondment, availability, interim or on leave.
- <u>Article 3.</u> Requests the Executive Secretary to put into effect the provisions of the revised Article 68 and to proceed with the necessary harmonization in the Manual of Administrative, Accounting and Financial Procedures in force.

HEREBY ADOPTS THE FOLLOWING REGULATION:

ADOPTING THE RECOMMENDATIONS TO BE SUBMITTED TO THE HEADS OF STATE AND GOVERNMENT AT THEIR 4TH ORDINARY SESSION

HAVING REGARD TO the Convention establishing the Pan-African Agency of the Great Green Wall, signed on June 17, 2010, in N'Djamena, Republic of Chad by the Conference of Heads of State and Government of Member States,

HAVING REGARD TO the Final Report of the Seventh (7th) Ordinary Session of the Council of Ministers held on July 29 in Nouakchott, Mauritania,

HAVING REGARD TO the upcoming 4th Ordinary Session of the Conference of Heads of State and Government of the Pan-African Agency of the Great Green Wall,

HEREBY ADOPTS THE FOLLOWING REGULATION:

<u>Article 1:</u> Adopts the Recommendations of the 6th Session held on June 30, 2018, in Nouakchott and the 7th Ordinary Session of the Council of Ministers held on July 29, 2021, as follows:

- (i) Appointment of the Federal Republic of Nigeria to host the 5th Ordinary Session of the Conference of Heads of State and Government.
- (ii) Appointment of the Federal Republic of Nigeria to hold the Presidency of the Conference of Heads of State and Government of the Pan-African Agency of the Great Green Wall for a two (02) year term.
- (iii) Approval of the 2021-2023 Roadmap of the Executive Secretariat of the PAGGW.
- (iv) Appointment of the new Executive Secretary of the Pan African Agency of the Great Green Wall.
- (v) Review of the annual statutory contribution rate of the PAGGW Member States.
- (vi) Call for voluntary contributions from Member States and technical and financial partners for the mobilization of funds for the construction and equipment of the headquarters.

<u>Article 2.</u> Decides to submit them for decision to the High Attention of Heads of State and Government during their next Summit.
